ARTICLES OF INCORPORATION OF LA VEREDA COMPOUND CONDOMINIUM

DEC

UNIT OWNERS ASSOCIATION, INC.

The undersigned, desiring to form a non-profit corporation under the laws of the State of New Mexico, certifies that:

I

The name of the corporation is La Vereda Compound Condominium Unit Owners Association, Inc.

II

The duration of the corporation is perpetual.


III

The purposes for which the corporation is formed are as follows:

- a. To administer, regulate and provide for the maintenance, repair, improvement, and replacement of all common elements owned by unit owners of La Vereda Compound Condominium.
- b. To regulate maintenance, repair and use of the units located in La Vereda Compound Condominium.
- c. To perform such acts as may be necessary in connection with the management and control of a residential condominium.
- d. To perform all the duties assigned to the

 Association in the Declaration of Condominium for La Vereda

 Compound Condominium ("Declaration") including the levying and



collection of assessments and foreclosing the lien of such assessments.

- e. To enter into, make and perform contracts of every kind and description with any person, firm, association, corporation, municipality, county, state or other political body.
- f. To borrow or raise monies for any of the purposes of the corporation and, from time to time, to draw, make, accept, endorse, discount, execute and issue promissory notes, drafts, bills of exchange, warrants, binds, debentures, and other negotiable or non-negotiable instruments, evidences of indebtedness, and security instruments.
- g. To maintain comfortable, safe, and sanitary nome surroundings in the residence community in which its members live.
- h. To preserve and enhance the natural environment of the area through the utilization of energy efficient, water conservation and environmental planning technology.
- i. In general, to carry on other business in connection with the foregoing, and to have and exercise all the powers conferred by the laws of the State of New Mexico upon corporations formed under the laws of the State of New Mexico, and to do any or all of the things hereinbefore set forth and all things incident and proper in connection therewith to the same extent as natural persons might or could do in any part of

the world as principals, agents, trustees, contractors or otherwise.

j. The objects and purposes specified in the foregoing clauses shall, except where otherwise expressed, be in no ways limited or restricted by reference to, or inference from, the terms of any other clause in these Articles of Incorporation, but the objects and purposes specified in each of the foregoing clauses of this Article shall be regarded as independent objects and purposes.

IV

The corporation shall have all the powers and privileges provided by law for non profit corporations incorporated under Section 53-8-5 N.M.S.A., 1978, and for associations of unit owners by the New Mexico Condominium Act, Sections 47-7A-1 through 47-7D-20 N.M.S.A. 1978 (1982 Repl. Pamph.).

V

The initial registered office of the corporation shall be:

Each owner of a unit in La Vereda Compound Condominium shall be a member of the corporation, and shall be entitled to one vote per unit owned, provided that multiple owners of one unit shall be entitled to only one vote among them. The corporation shall have no members, other than unit owners. An owner or owners may delegate an agent to act a proxy on his or their behalf.
