- UNIT DEFINITION FOR ALL UNITS (EXCEPT UNITS 16, 17, 18 AND 19) CONSIST OF THE SPACE WITHIN THE OUTER SURFACE OF THE ROOF OF THE UNIT, INCLUDING ANY SKYLIGHTS, CHIMNEYS AND THE ENTIRE SURFACE OF THE PARAPET WALL, THE UPPER SURFACE OF THE FINISHED MASONRY SLAB TO WHICH THE FINISHED FLOOR IS ATTACHED, AND THE VERTICAL PLANES COINCIDENT WITH THE EXTERIOR WALLS AT GROUND LEVEL EXTENDED TO THE INTERSECTION WITH THE UPPER AND LOWER HORIZONTAL BOUNDARIES.
- UNIT DEFINITION FOR UNITS 16, 17, 18 AND 19 CONSIST OF THE SPACE WITHIN THE LOWER SURFACE OF THE CEILING, ABOVE ANY PAINT OR PLASTER, THE HORIZONTAL PLANE OF THE UPPER SURFACE OF THE SUB-FLOORING, AND THE INNERMOST SURFACE OF THE EXTERIOR WALLS BOUNDING THE UNIT UNDERNEATH ANY PLASTER OR PAINT, EXTENDED TO INTERSECTIONS WITH EACH OTHER AND WITH THE UPPER AND LOWER BOUNDARIES.

- LIMITED COMMON YARD WALLS SHARED BY TWO UNITS ARE TO CENTER OF WALL
